Mission

The mission of Adaptive Sports Partners of the North Country is to provide year-round opportunities in sports and recreation for persons with physical or developmental disabilities.

Adaptive Sports and Recreation

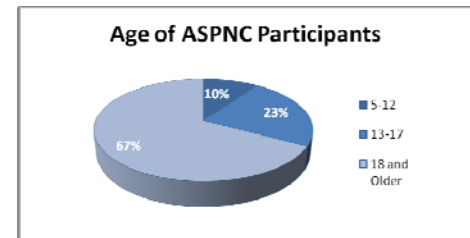
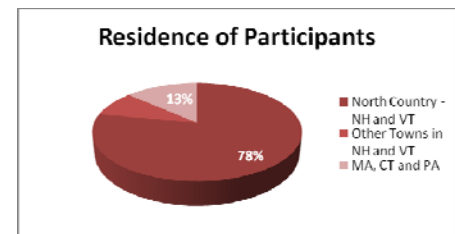
Participants

A total of 82 persons with disabilities took part in ASPNC's adaptive services.

TYPES OF DISABILITIES - Some participants had diagnoses of physical disabilities. Others had diagnoses of developmental or intellectual disabilities. A few had diagnoses which were a combination of physical and developmental diagnoses.

RESIDENCE - Sixty-four participants came from communities in the North Country. Seven came from other towns of New Hampshire and Vermont, while eighteen came from Massachusetts, Connecticut, New York and Pennsylvania.

AGE - Participants ranged in age from 6 to 61. Eight were age 5-12, nineteen were age 13-17, and fifty-five were age 18 or older.

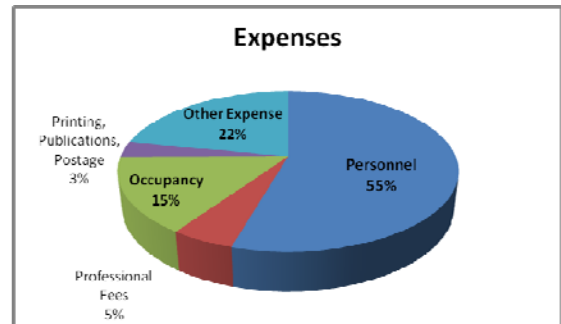
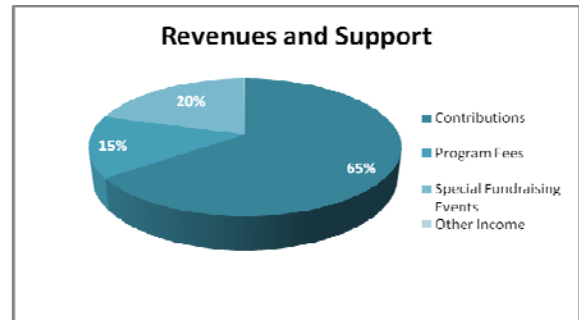
